# **ONLINE PRIVACY POLICY AGREEMENT**

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. ## **Use of Information Collected**

Health One P.A. does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Health One P.A. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. #### <u>Security</u>

Health One P.A. takes precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.
